Appropriate service provider shall be selected on the basis of interview and panel discussion by the designated team for the purpose. Final rates and payment terms and conditions shall be finalized on the basis of the same. The date and venue of the interview will be intimated through telephone and email.

Scope of work

To supply broiler day old chicks to Kerala chicken farms in all districts under KBFPCL based on the demand and purchase order given by the Producer company. Supply and logistics should be carried out by the vendor.

Eligibility criteria

The company or agency should have a minimum experience of 3 years in supplying of chicks. The applicant must be a profit-making organization for the last 2 years.

Chick specifications:

- The day old chicks (DOC) should be COBB breed (430 Y).
- Chicks should have homogeneous weight of 40 gms with maximum 5% acceptable variation.
- Male : Female Ratio should be a minimum of 50 %.

Terms & Conditions

- The empanelled agencies have to supply broiler day old chicks (DOC) for the company with the above given specifications.
- If the qualities of the chicks supplied are not up to the standards, the rate of the chicks should be returned to the company as penalty within 28 days of the supply.
- An experienced veterinary doctor should visit the farms, randomly check and ensure the quality of the birds.
- Payment will be made within two weeks.

Selection Criteria

- The companies / firms should submit documentary evidences at the time of interview. The documents required are mentioned in annexure
- The sealed quote should be submitted as per the format mentioned in the annexure
- Based on the documents furnished, the individual agencies will be evaluated by a committee.
- Based on the evaluation of the documents furnished by the agencies, the list of qualified agencies will be published and the sealed quotes furnished by all the qualified agencies will be opened and evaluated by committee on the same day in the presence of representatives of all the qualified agencies.
- The lowest quoted agencies will be empanelled temporarily and have to execute an agreement with KBFPCL for chick supply . If the chicks supplied are below standards, the KBFPCL company will cancel the agreement and consider the next empanelled service provider.
