Requirements and Specifications

As a part of Kerala Chicken project Kudumbashree Broiler Farmers Producer Company Ltd has invited applications from vendors for supply of poultry broiler feed to farms within district.

- Should have a feedstore with a minimum area of 500 sqft and maximum area of 2000 sqft with all the necessary arrangements to store feed in a safe and secure manner
- Feed delivery upto farm should be carried out by the vendor
- Feed supply to all KBFPCL farms within district must be done by the vendor and outside district if necessary upon request.
- All loading unloading should be entirely done by the vendor thus should possess adequate staff for the same. Under no circumstances the farmer should be burdened with loading or unloading in the farm.
- Vendor will be paid a sum for the total bags (on the basis of rate per bag delivered) delivered to KBFPCL farms. Thus vendor can quote the delivery charge for one bag including loading, unloading and freight charges.
- Vendor should submit the abstract of feed delivered by month end and the payment will be done within a week
- Vendor should have two vehicles Minimum (3 Tonnes and 9 Tonnes or above) for supply, based on the requirement within a district.
- The contract period will be for one year from the date of agreement. If the KBFPCL company so desires the contract may be extent further during this period of contract, rates and other condition will not be changed under any circumstances.
